Motion by Craig DuMond to accept minutes as corrected, seconded by Jeri Brayman, all in favor carried

FLOORTIME:

- 1. Steve Tiska asked how things were going with the side walk. Mike said he just received a pile of mail on grants and has not been able to look at it yet. Mike said he will be going through them in the next week or two.
- 2. Steve asked about the pipe line and asked where that is at. Mike said he will report on this later in the meeting.

HIGHWAY REPORT:

- 3. Plowing and sanding roads as needed
- 4. Cleaned up downed trees on Teed Hill, Parker Hollow and Pine Hill Rd
- 5. Cleaned and repaired shop furnaces
- 6. Received 200 gallons of waste oil for shop heat
- 7. Installed an old dump box on the 2008 Freightliner

- 8. The Town was chosen for a candidate for a new "Test" plow blade. Its value is \$800.00, the Town only needs to give the results and the snow plow is free
- 9. Currently working on the "WEX" fuel program. This is a vendor the Delaware County Sheriff uses for fuel in their vehicles
- 10. Chuck inspected the street sweepers and choose the best unit for the Town. The Board just needs to approve the purchase so that it he can proceed with the purchase order

Motion by Craig DuMond to approve the purchase of the sweeper from J&J, seconded by Jeri Brayman, all in favor carried

Chuck asked when Karen do the end of the year books. Mike said she will do it, but has to wait until all the bills are in for 2014. Mike said she will come to the meeting if asked.

Mike asked that if there was any money left over in the 2014 Highway budget, could it be put into the Highway equipment reserve fund. The Board and Supervisor agreed but, that a permissive referendum with have to done to this.

OLD BUSINESS:

11. Mike said the DPW discussed with other Towns involved with the Constitution Pipeline, a road use agreement. This was done at a meeting with the Pipeline people. It was given to the pipeline representatives to approve. They said they would have to let the lawyers look it over to see if it meets with their approval. They said that they would set another meeting towards the end of January to discuss any changes, if any. Mike said if settled it will be adopted by the Town and should hopefully be ready by the February meeting.

Steve said the road that goes to the new tower is in rough shape. He has his concerns about the County fixing it first before it is looked at by the Pipeline Company. Mike said he will have Wayne Reynolds go look at it, but in the road use agreement, no roads will be surveyed until after the thaw has settled all the roads.

12. Mike said he received the bond paperwork for the New Town Hall from the Town Clerk (Pam). He is going to take this to the Lawyer, to have them determine what

has to be done to get the balance of the unused bond monies into this year's budget (2015).

NEW BUSINESS:

- 13. Mike discussed the audit done by the Teamsters Union. The unions usually audit the books every year, however they never audited Masonville before. They verified that all benefits were up to date and current.
- 14.On a different note the Teamsters sent the Town a bill for late payments on benefits for the highway workers. For some reason, they started sending the bills to the Highway dept. address. They were requesting a little over \$1,000.00 in late payment interest penalties. After reviewing this problem, it was found that prior to this, the invoices were being sent to the bookkeeper, and not to the Highway dept. When Chuck received them, he just put them through the usual payment method at our Town Hall meetings. That made us loose two or three weeks before the bookkeeper received the invoices. It was probably another two weeks before the Union received payment. Chuck called the Union to explain the problem and the Union agreed to dismiss all of the penalties and change the address back to the bookkeeper.
- 15. Mike said a check was received for a CHIPS payment for \$13.500.
- 16. Mike said he was in contact with Frontier telephone to get a price for the Towns phone and internet service. If the Town uses them, it would cost \$169.94 per month, which would include unlimited local and long distance and high speed internet. This would be a savings of a little less than half the cost of Time-Warner. Mike asked if he could pursue this and the Board said most certainly.
- 17. Mike said he received the final paperwork on the \$100,000.00 grant. He said he is ready to fill out all the

forms that the State is requesting and secure the funding from the bank. This will be a great deal for the Town once the garage bays are built as we will be getting rent from the County DPW each month. This will add \pm \$60,000.00 a year to the Towns revenue.

- 18. Mike said he is going to need a resolution for Department of Public Works for drug testing for all of the CDL drivers. We do it under the county contract, as it is much cheaper.
- 19. Mike asked if the Board reviewed the Justices paperwork. They said agreed.

Motion by Craig DuMond to approve the Town Justices paper work, seconded by Jeri Brayman, all in favor carried

COMMITTEE REPORTS:

Steve Roff read the CEO report for the Month of December and also the yearly report.

- 13. Upon Recommendation of the Town Supervisor: the Town Clerk, before 1/10/2015, file with the State Department of Audit and Control, the names and addresses of all Town Officers, either elected or appointed. And further file with the State. So moved by Craig DuMond, seconded by Jeri Brayman, all in favor carried.
- 14. Upon recommendation of the Town Supervisor: the Town Clerk certify to the Delaware County Clerk, within 20 days of appointment, the names addresses and Oaths of Office documents of all Town Officers, both elected and appointed. - 15. MINUTES:

Motion by Craig DuMond to accept minutes as presented, seconded by Jeri Brayman, all in favor carried.

FLOORTIME:

- 38. Al Williams spoke on Bundy Hollow Road and how it is falling apart. Chuck said yes it is getting worse, but said that the Town has to take care of the worst roads first. Those that are most traveled, but he will see what he can do. Steve Tiska asked if the Town had some sort of schedule on roads, then it would be taken care of in a cycle. Chuck said that it should be on a 3 to 5 year cycle but the Town does not have enough money to do this.
- 39. Chuck is going to check with County on Pine Hill Rd. and he wants to see what they are doing to the Road while they are building up there.

CORRESPONDENCE:

- 40. Mike spoke on the Town Insurance and said it will cost the same as last year.
- 41. Mike said that Teamsters had a problem last month with a late payment on an invoice and it was because they sent it to the wrong address. Mike said they did this before and sent bills to the wrong address. This problem will have to get resolved by them, as this was the second time it happened.
- 42. Mike said the Fair board is looking again for money to help pay for T-shirts for the 5k run. The board agreed not to make a donation.
- 43. Mike said he had a letter from Upstate Towns on the State Tax freeze program, and that State Government efficiency plan is due by June 15, 2015. To date the State has not qualified what they consider to be an efficiency.
- 44. Mike said NYSAC has a pamphlet on Agricultural discount on Electric and was passed out.
- 45. Mike said the Comptroller's office requested a response to the Highway audit they did last year. They revised the one they sent us last year. Mike and Chuck worked on it and sent it back to them. Mike said the State wants us to hold the budget to a 2% increase, while they want us to spend 1.5 million dollars on re-paving the roads. Mike said he would like to know who taught them the form of math that they use.
- 46. Mike read a letter from the Lawyer referencing the balance of the bond money reserve, and he said a permissive referendum is not required to pay this year's principle from the reserve. The balance of the reserve could be applied to help pay down the 2016 principle.
- 47. Mike said he has just learned that the Town owns a right of way on Thorpe Hill Road. That being the case, the Constitution Pipeline will have to pay the Town \$2,000.00 to cross it.

HIGHWAY REPORT:

- 48. Plowing and sanding roads as needed
- 49. Replaced front spring on the 1999 plow truck
- 50. Serviced the loader and a couple of trucks
- 51. Received 55 gallons of waste oil for shop heat. Our reserve waste oil will be on empty at the end of the heating season
- 52. The sweeper is here and they installed a plow that was removed from our parts pickup. The plow will loosen road sand to make sweeping quicker in the spring
- 53. Repaired a major electrical issue with the 2006 plow truck
- 54. Removed the 1988 Mack and the vacuum truck from the insurance, but did need to add the 2008 Freightliner to satisfy federal compliance
- 55. They have been busy chasing diesel fuel since the pump at the store is out of service. The new WEX cards arrived just in time to purchase fuel

Chuck said that Gordy's truck the 06 International is rotting at the cross member to the bed. It ripped off under the weight of the grit they were spreading. Chuck said they are going to make a new piece and weld it themselves and see if it can by more time with it. Steve said that it also needs a kill switch on it.

OLD BUSINESS:

Mike said that Frontier phone Co. prices are less expensive than Time Warner, but is waiting for written quotes to confirm it.

COMMITTEE REPORTS:

Steve read the CEO report for January

SUPERVISORS REPORT:

- 56. Mike said the State Comptroller's Office was given a recommendation from the Town and the first draft was answered waiting on the seconded copy to look over before a new answer is given.
- 57. Mike spoke on the Board of Supervisors meeting and there was a lot of gripping from the Hamden Supervisor about raises for \$8000.00 a year for 10 department heads. That would be an \$800.00 a year raise. That would about \$16.00 a week before taxes. He blamed the County for this and Mike finds this very upsetting. With all of the unfunded mandates that NY State lowers on all the Towns and Counties, (in the billions of dollars) that Supervisor is blaming the County. The County keeps losing really good people to the State and private sector because they can't make ends meet. Replacing these people cost much more money than the pittance of a raise that was granted to the Department heads.

MINUTES:

Motion by Mike Spaccaforno to accept March minutes as presented, motion was accepted.

FLOORTIME:

- 96. Steve asked about an item in the Walton reporter referencing a road use agreement for the pipeline. Mike said he would discuss this later in his Supervisor's report.
- 97. Jeri asked about seasonal roads signs and the different dates. Chuck said some of them have the wrong dates on the signs. He will get them corrected so they are all the same.

CORRESPONDENCE:

98. Mike spoke about the Road Management Plan from the State comptroller's office. The report told the Town how it should do its road repair. Mike said the costs were based from an outdated cost perspective from the late 1970's. Mike also said that he and Chuck responded to all their allegations in the report. All of the recommendations that was made to a lack of record keeping

were incorrect. The Town produced all of the required paperwork and proof of complication of all the work that was done.

- 99. Mike spoke on the road to the Pine Hill Tower and how the Town did not want the County to use any heavy equipment on the road until all the frost is gone. Mike said that he was in contact with Wayne Reynolds and they have no intention on ruining the roads, he said if they damaged it they will repair it.
- 100. Mike said" Solarized Southern Tier" has asked to use the Town Hall. This is a non-profit organization that would like to connect interested parties with any information on solar panels and also with installers. They would give you any and all information that one may require. Mike said in order for them to use the hall, they would need to produce proof of Insurance, with the Town of Masonville listed as additionally insured and with an additional Hold Harmless clause included. That would release the Town of any liability. Mike said they would like to tentatively use it April 12th. They would advertise it locally.
- 101. Mike said he received an email from Tennessee pipe line on upcoming open houses and said all of the dates are in the paperwork on the desk.
- 102. Mike said he received notice from the County that they would be ending the rental on March 31st. The Town received \$12,000.00 of revenue from this rental and the County is committed to rent again next year.

HIGHWAY REPORT:

- 103. Plowed and sanded as needed
- 104. Used Loader to push up drifted areas
- 105. Started to restock the sand inventory
- 106. Thawed the sewer line and had the septic pumped out
- 107. Replaced rear brakes on truck #6
- 108. Installed new wood deck on the equipment trailer
- 109. Repaired hydraulic lines and brakes valves on truck#3
- 110. Getting items to surplus and list on an internet auction

- 111. We tested the cost of the WEX fuel card and compared the same to the Mirabito cost they are just about equally priced. We will use WEX cards in cases where needed, such as if pumps are out or if there are no Mirabito's around.
- 112. The Military truck we set up as only a dump truck has proven to be our best truck overall. Chuck would like the Board to consider one or two more before they are not available. To finance this Chuck would sell the older Military truck to cover purchase cost and also the changeover.

OLD BUSINESS:

- 1 Mike said he is still working on the Frontier and Time Warner billing, the lady at Frontier is on maternity leave right now.
- 2 Mike said he has some good leads on sidewalk grants, as they are out again. Mike spoke on maybe doing a farmers markets in Town. He will start asking around to see if enough people are interested in getting involved in it.
- Mike spoke on the Road Use Agreement (RUA) to be used with the Constitution Pipeline. He discussed how the Town's RUA will mirror the County's agreement, less the references to truck weights going over the bridges in the County. To date the Pipeline has not responded to the agreement. Construction has been delayed by the NY State DEC until the bat population has finished it's mating season.

NEW BUSINESS:

- 1 Mike said that CHIPS money is staying the same as last year. The state has also renewed the pothole money and has increased the amount to the County's by \$50 million dollars.
- 2 Mike spoke on a new website for Masonville. Its grant funded campaign by a non-profit organization. It would cost the Town \$750.00 and is specific to municipalities. Mike said that is an interactive site that the constituents can keep in in touch with all of the elected officials. Each department or committee can post and update any information that they would like to get out to the public. All laws, regulations, forms etc., can be immediately obtained by anyone. Mike feels that this item should be put in the budget.

COMMITTEE REPORT:

1 Steve Roff read the CEO report for March.

SUPERVISOR"S REPORT:

Mike said while at a conference in Margaretville, he was speaking with Shelly Johnson from Delaware Co Planning about Camp Brace. Mike said the camp cannot be used by the Town, but he would like to try to get the owners, NYS DEC to turn it over to the Town of Masonville. We can than attempt to have a business purchase the land. This action will put it back on the tax rolls and hopefully create jobs in our community. Mike said that he was also in contact with Glenn Nealis of the County IDA and NYS Assemblyman Cliff Crouch to have them help us to accomplish this.
